Security in 1970 and was renamed the Division of Public Safety under director Charles Riley in 1984. The department would remain as the Division or Office of Public Safety until the early 2000s when the University Police took over as the main safety/security office on campus.

## Content Description

The majority of this collection consists of Annual Reports from the Division of Public Safety from various years between 1984–2019. The collection also contains various safety policies and reports primarily from the 1970s.
